#### III. OBJECTIVES:

The Objectives of the Trust shall be:

- 1. To work with the people living below poverty line, women, dalits, adivasis, minorities and weaker / deprived sections, towards a just and equitable society.

- 3. To promote education through by establishing vocational training institutes, adult education centers, bridge schools and for youth, illiterates, school dropouts, street children, child labour, physically challenged, etc.
- 4. To organise vocational training courses, i.e. repairing electronic and electrical commodities, printing, carpentry, masonry, tailoring, embroidery, lace works, cane and bamboo works, carpet weaving, coir works on sarees and clothes, leaf plates making, cottage / hand loom and all other works related to village industries for the unemployed youth / women.
- 5. To encourage women by formation of self help groups (SHGs) and ensure that all the SHGs get the financial assistance/micro finance (loans) from financing agencies.
- 6. To promote community health, maternity and child health and organise health awareness camps relevant to sanitation, hygiene, nutrition, family planning, immunization / vaccination and eye problems / diseases, etc.
- 7. To campaign on preventive mechanisms for eradication of malaria, tuberculosis (TB), HIV, AIDS, etc. and provide medical help to the people already affected with these health problems / diseases.

8. To promote environmental protection, community forestry initiatives and agricultural extension works through by waste land development programmes.

- 9. To train the rural farmers in animal husbandry, agriculture, sericulture, horticulture, aqua culture, bee culture, tapsi culture (kovel / tapsi plants), etc. initiatives.
- To work towards relief and rehabilitation of people affected due to natural calamities and mining, irrigation and other development projects.
- 11. To organise awareness trainings / workshops / campaigns against all kinds of social evils i.e. untouchability, double glass system, jogini system, dowry system, child labour, bonded labour, witchcraft, sorcery, black magic (banamathi / chillangi), etc.
- 12. To develop and strengthen networks of agencies working in the field of socio-economic development.
- 13. To conduct such other activities that may be necessary to further the objects of the Trust. The trust may do all deeds, acts and things necessary for the furtherance of the objects of the Trust, but shall not include any activities of profit. Its income shall be applied only for public charitable purposes/objects of the Trust.

#### V. TRUSTEES:

- The Board of Trustees shall have nine members as Trustees.
- 2.a. The First Board of Trustees, whose term of office, as also that of any coopted members, is for a period of five years from the date of registration of the Trust Deed, shall consist of the following:

Ms. Sujatha Batthula Trustee
Ms. Tripura Sundari Gollapalli Trustee

- 2.b.The First Board of Trustees may coopt additional Trustees numbering up to 5, notwithstanding procedures for inducting Trustees into vacancies subsequently as laid down hereunder in Chapter V, articles 4 & 10 and Chapter XI, article 4.
- Each trustee shall hold office for a term of five years, which can be extended further. The Board shall strive to appoint persons as Trustees with care, on the basis of their subscribing to Trust's objects and similar objects whenever filling vacancies.
- 4. The board shall strive to nominate persons as Trustees with care, on the basis of their subscribing to similar objects, whenever new persons are appointed to vacancies. Such new persons should be from among lists recommended by joint deliberation of structures comprising of staff and representatives of project partners.
- 5. The retiring members can be renominated at the expiry of their term of office, the renomination being done by the continuing members by consensus or vote. One trustee is always nominated on the recommendation of other fraternal bodies.

- 6. All Trustees shall be Indian nationals ordinarily resident in India.
- 7. A majority of the Trustees shall be women.
- There shall be a Managing Trustee chosen by, and from among the Trustees, to look after the functions of the Trust, subject to the first Managing Trustee being the person named above.
- 9.a. There shall be an Executive Secretary appointed by the Managing Trustee in consultation with the other Trustees for a term of five years.
- 9.b.The Executive Secretary shall be appointed from among the staff of AMMA SEVA SADANAM i.e. the Trust. Until such time that the Trust has staff, the Managing Trustee in consultation with the other Trustees shall appoint a suitable person as Executive Secretary.
- Casual vacancies in the Board of Trustees shall be filled up by the continuing Trustees for the unexpired part of the term after a consultation between the Trustees and the staff of the Trust.
- 11. The Board of Trustees shall meet at least once a year and as often as necessary at the registered office of the Trust or at such places as they may decide from time to time.
- 12. Any business requiring urgent approval by the Board of Trustees shall be transacted by circulation among the Trustees by Executive Secretary in consultation with the Managing Trustee and their approval obtained by correspondence. Such approval shall be placed at the next meeting of the Board for ratification.
- 13. If any Trustee carries out any action detrimental to the interest of the Trust or his/her continuance is detrimental to the Trust, such a Trustee shall be removed from the Board of Trustees after giving him / her an opportunity to explain his/her position, by a majority vote in the meeting of the Board and the fact shall be intimated to the Trustee in writing.
- 14. The Trustees, including the managing Trustee, as also the Executive Secretary will fuction in an honorary capacity, and the person among the Trust's staff who may function as Executive Secretary of the Trust draws salary only as a staff member of the Trust, and not as Executive Secretary.

### VI. PROPERTIES VESTED IN THE TRUST:

a) The Board of Trustees shall hold the properties or funds which may hereafter belong to the Trust and expend the income arising ther of for the use and purpose of the Trust and the institutions, if any, under the Trust.




- b) The Trust may receive funds from the Governments, State and Central, National and International foundations, funding agencies, individuals and institutions, to further its objectives.
- c) The Board of Trustees shall, from out of the income thus realised, expend such sum or sums of money as it may deem fit and proper towards the maintenance of the properties of the Trust in good and tenantable condition and meet all expenses which the Board of Trustees may think necessary for the proper management of the Trust and for carrying out its programmes efficiently.

# VII. POWERS AND DUTIES OF THE BOARD OF TRUSTEES:

- a) The Board of Trustees shall be in complete management of the Trust and they shall formulate rules and bye-laws for the effective management of the Trust and amend the same from time to time to meet all exigencies through procedures laid down in the initially formulated bye-
- b) The Trustees shall have powers:
  - i. To lay down the polices for the work of the Trust and review it from time to time.
  - ii. To recommend, sanction, grant or give donation to other institutions with similar objects.
  - iii. To receive/ reject donations in any form, to raise funds by advertisements, in publications organized by the Trust, by organising cultural shows, by accepting fee, by service charges, by contributions and by subscriptions.
  - iv. To purchase or take on lease lands, buildings, equipments, materials and things, to etect and maintain buildings and other constructions and to sell, mortgage, dispose of or otherwised deal with all or any of the same as the Board kof Trustees may think fit and proper.
  - v. To grant loans or borrow sum or sums of money as they may think fit and proper, to control and manage the assets of the Trust and to execute, become party to, sign, acknowledge, perfect and register all deeds, agreements, contracts, amounts, receipts and other documents and writings and to give effectual discharge on behalf of and against the Trust.
  - vi. To borrow from time to time such sum or sums of money at such interest for such period and on such terms with or without security movable okr immovable, as the Board kof Trustees may think fit and to secure payment thereof with interest by mortgage or by bond, promissory notes and other negotiable securities.
  - vii. To institute, conduct, defend, compound, withdraw, compromise, adjust, refer to arbitration or abandon any legal or other proceedings, claims or disputes by or against its officers or employees concerning the affairs of the Trust and to sign and verify vakalats, plaints, written statements, affidavits and other documents.

To appoint from time to time, staff, professional, technical, non-technical and other, with such powers and duties and upon such terms as to duration of office, remuneration or otherwise and at any time to suspend, dismiss, terminate, or discharge any or such of them as the Board of Trustees shall think proper or necessary.
  - ix. To open and close accounts in the name of the Trust in any scheduled bank, Post Office, and to operate on such accounts and otherwise deal with the same.
  - x. To insure and keep insured, if deemed expedient, all or any of the buildings and other assets of the Trust.
  - xi. To invest surplus funds, if any, of the Trust in securities approved by the law relating to Trusts as per IT Act 1961, or in such manner as the Board of Trustees may think fit and proper in the best interest of the Trust.
- xii. To delegate to the Managing Trustee all or any of the powers, authorites and directions vested in the Board of Trustees and generally to carry out such transactions as the Board of Trustees considers expedient in the best interst of the Trust and to make all such arrangements and such acts and things on behalf of the Trust as may be usually necessary, desirable or expedient in the management of the affairs of the Trust or in carrying out the objectives of the Trust.

#### VIII. MANAGING TRUSTEE:

- The Managing Trustee shall be chosen by the Trustees from among themselves, after the term of the first Managing Trustee, named above, concludes.
- The Managing Trustee's term is governed by provisions of Article V above, and for purposes of retirement, renomination and termination of membership, the Managing Trustee shall be considered a Trustee.
- The Managing Trustee shall preside over the meetings of the Board of Trustees and in her/his absence, the members present may elect a Chairperson for a specific meeting.
- The Managing Trustee shall carry out faithfully such responsibilites as may be delegated to her/his by the Board of Trustees from time to time.
- The Managing Trustee shall represent the Trust and may sue or be sued in the name of the Trust.

#### IX. ANNUAL CONSULTATIVE MEETING:

The Board of Trustees, through its Managing Trustee and appointed Executive Secretary and
other staff, shall convene an annual consultative meeting of all those groups, bodies and
institutions with which the Trust works in a preceding year. The subjects to be discussed in

### X. OPERATION OF BANK ACCOUNT:

### XI. MAINTENANCE OF BOOKS OF ACCOUNTS:

Regular books of accounts of the Trust shall be maintained and the same shall be got audited by a Chartered Accountant every year.

### XII. AMENDMENT OF THE TRUST DEED:

The Trust Deed may be amended by a resolution passed by a majority of not less than two-thirds of the Trustees present and voting in a meeting of the Board of Trustees called for the purpose. Any addition, alteration or deletion to the existing objects of the Trust shall be made only with the approval of the Commissioner of Income Tax concerned.

#### XIII. FUNDS:


